COOKIES

This website uses cookies to ensure the integrity of the registration process and to customize the website. A cookie is a small text file a Web page server stores on your hard disk. It cannot be used to run programs or infect your computer with viruses. Cookies are uniquely assigned and can only be read by the Web server on the domain that assigned the cookie to you.

Cookies are designed to save time. For example, if you customize a Web page or consult a website, a cookie helps the website to recall your specific information the next time you visit. This simplifies the delivery of content of interest to you and your use of the website. When you return to the website, the information you previously provided is retrieved so you can readily use the features of the website that you customized.

We may also use pixel tags, or transparent GIF files, to help deliver cookies. We use this technology to compile statistics on the use of our website. We may share aggregate statistics with our partners but we restrict them from placing GIF images or cookies on our website, unless there is a clear short-term benefit for our customers (i.e., by integrating a service from a website based on third-party cookies or transparent GIFs).

You may choose to allow or block cookies. Most Web browsers automatically allow cookies, but you can block cookies in your browser settings. If you block cookies, you may not be able to fully enjoy the interactive features of this website or others that you visit.
